The applicant is requesting relief from one (1) provision of the Township of Tay Zoning By-law 2000-57 as amended, the request is to permit the construction of a new single detached dwelling and detached accessory building with a front yard setback of 1.53 metres for the dwelling and 5.0 metres for the detached accessory structure, whereas 7.5 metres is required.


