## COMMITTEE OF ADJUSTMENT NOTICE OF MEETING FILE NO. 2025-B-05

This is a matter of an application made pursuant to Section 53 of the *Planning Act* to the Committee of Adjustment submitted by Kennedy Self on behalf of Dr. Gibbs owner of a vacant lot, legally described as Tay Concession 8 and 9, Part Lot 15, Part Road Allowance, Registered Plan 51R20376, Part 1 Registered Plan 51R35543, Parts 7, 10, 13 to 15, Township of Tay.

The purpose and effect of this application is a boundary adjustment for a portion of the vacant lot described above which is to be consolidated with 335 Robins Point Road. See below a chart and key map showing the proposal:

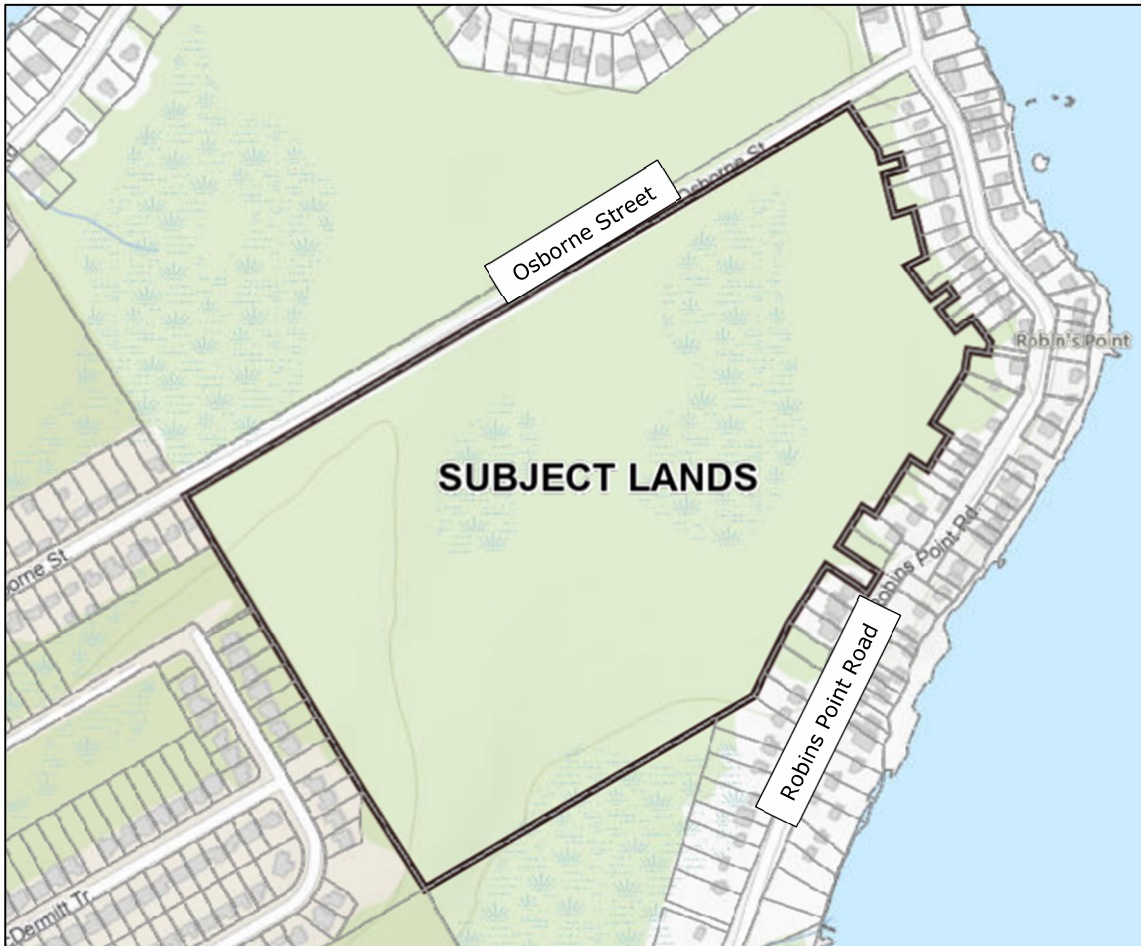

If you wish to be notified of the decision of the Committee of Adjustment in respect of the proposed consent application, you must make a written request to the Secretary-Treasurer

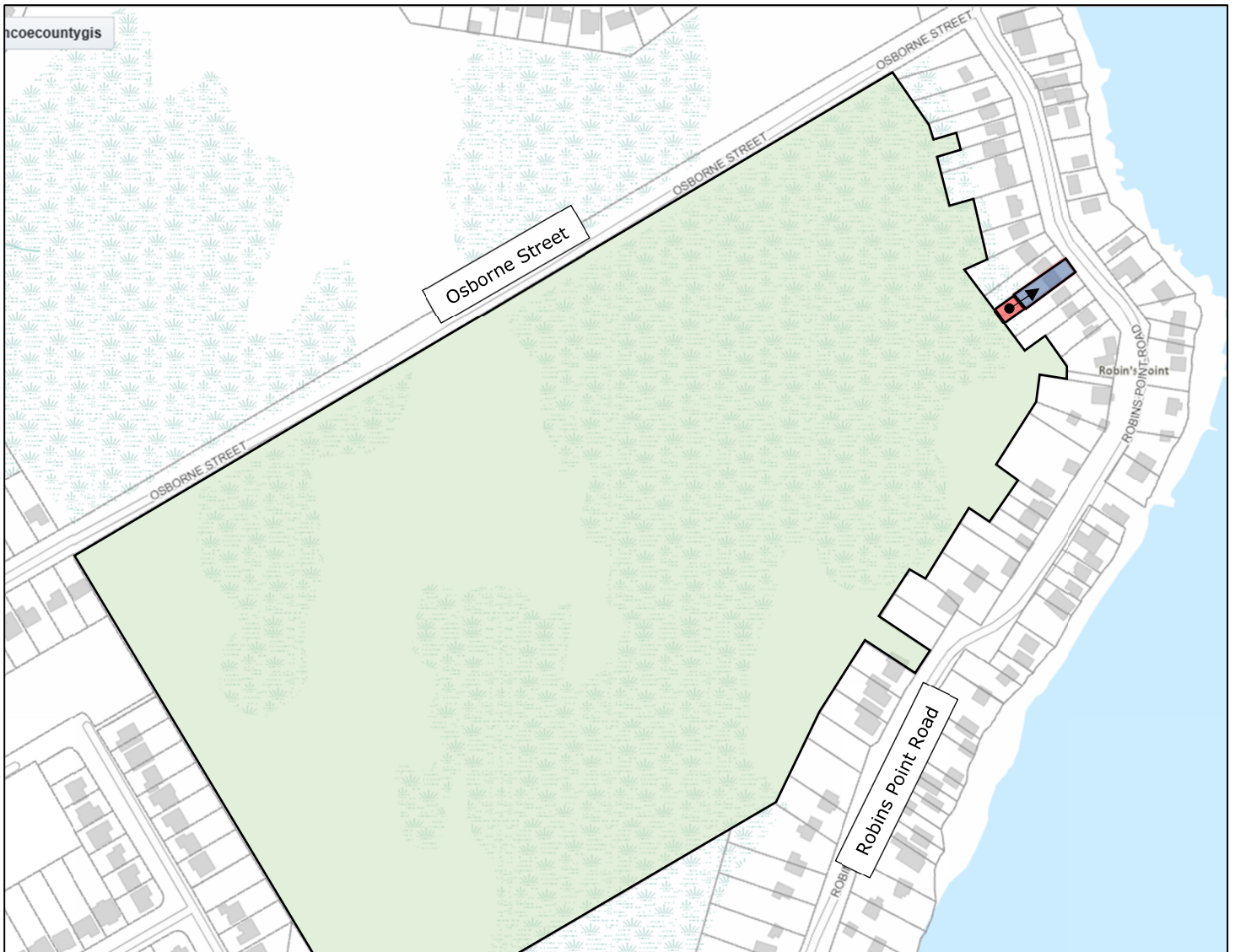
