COMMITTEE OF ADJUSTMENT NOTICE OF MEETING FILE NO. 2025-A-15

This is a matter of an application made pursuant to Section 45 of the Planning Act to the Committee of Adjustment submitted by Brendan from de Koning Group Inc. on behalf of Brad Pearsall, owner of **6692 Highway 93**, legally described as Concession 1 South, Part Lot 78, Registered Plan 51R14198, Part 2, Registered Plan 51R20731, Part 1, Township of Tay.

The applicant is requesting relief from one (1) provision of the Township of Tay Zoning By-law 2000-57 as amended. The applicant is seeking permission to construct a lien-to addition to the existed detached garage with a reduced interior side yard setback of 3.9 m (12.80 ft) whereas, a side yard setback of 6.0 m (19.69 ft) is required.

The below chart summarizes the required and proposed reliefs:

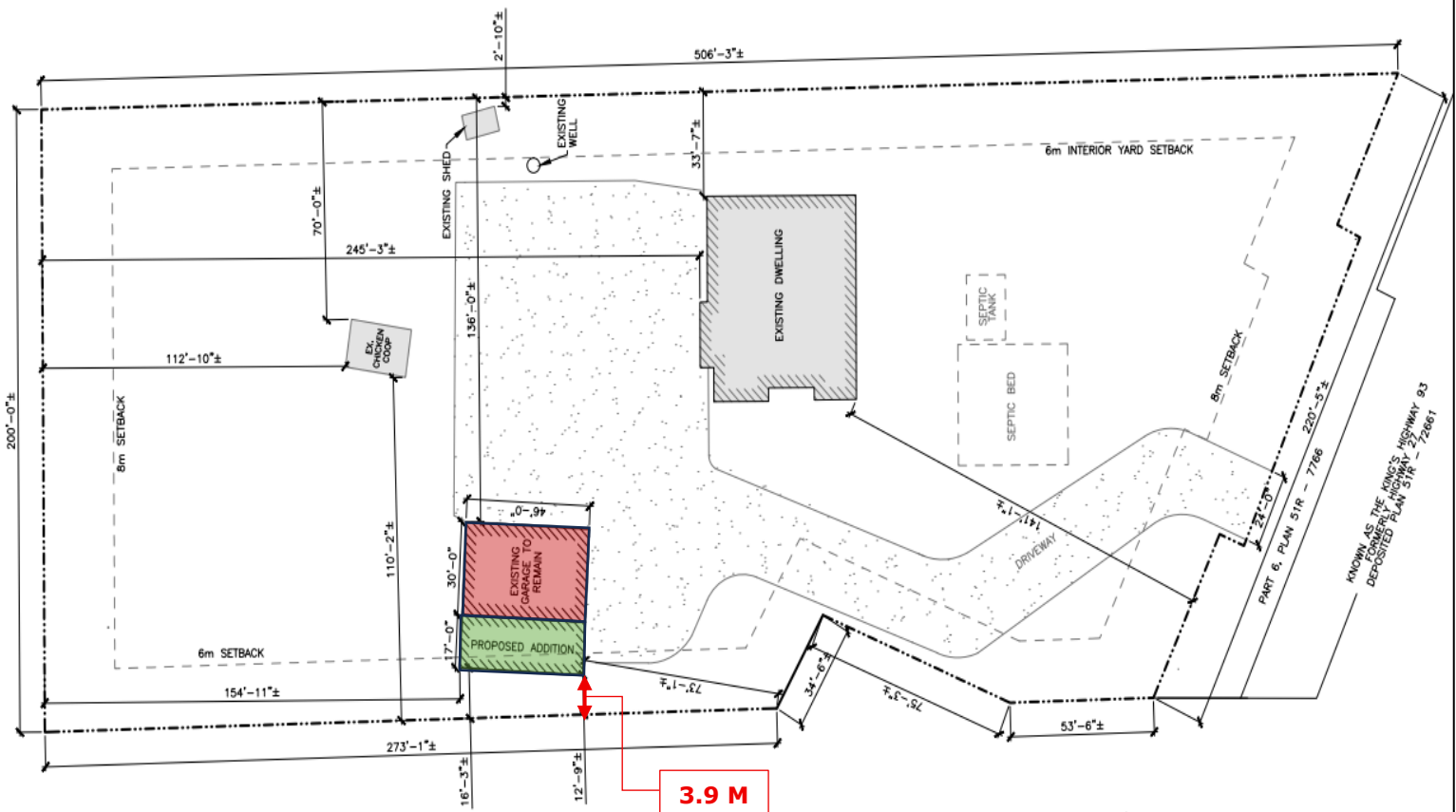
If you wish to be notified of the decision of the Committee of Adjustment in respect of the proposed minor variance, you must make a written request to the Secretary-Treasurer.
