## COMMITTEE OF ADJUSTMENT NOTICE OF MEETING FILE NO. 2024-A-18

This is a matter of an application made pursuant to Section 45 of the Planning Act to the Committee of Adjustment submitted by Peter Stefanac on behalf of David and Kimberly Kennedy, owners of **15 Tanners Road**, legally described as RCP 1725, Lot 16, Registered Plan 51R21724, Parts 1 and 2, Township of Tay.

The applicant is requesting relief from two (2) provisions of the Township of Tay Zoning By-law 2000-57 as amended, to permit a pre-fabricated shipping container with cladding and roof and height of 2.8 metres (9.18 feet), whereas no pre-fabricated shipping container is permitted in a residential zone and a maximum height of 2.5 metres (8.20 feet) is required for an accessory building 15m<sup>2</sup> or less in area.

The below chart summarizes the required and proposed reliefs:

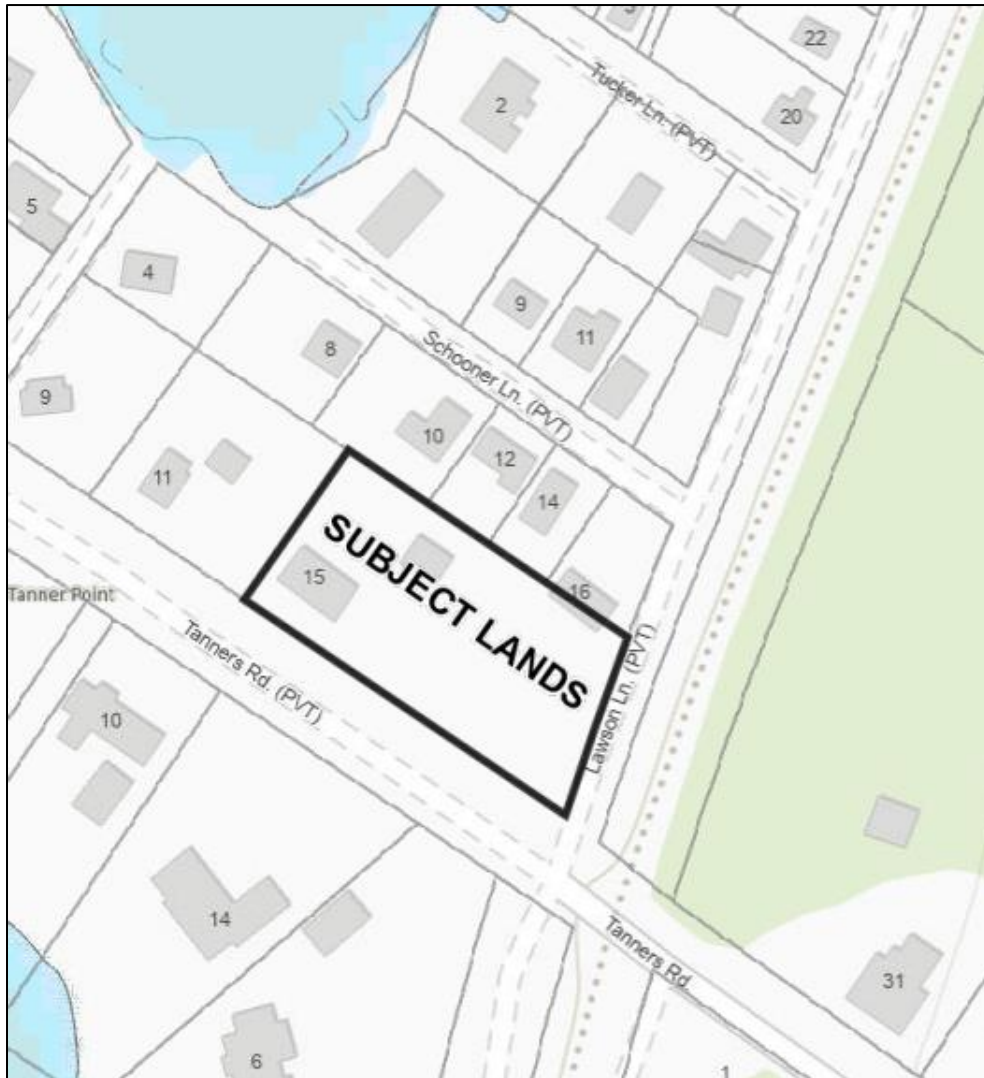

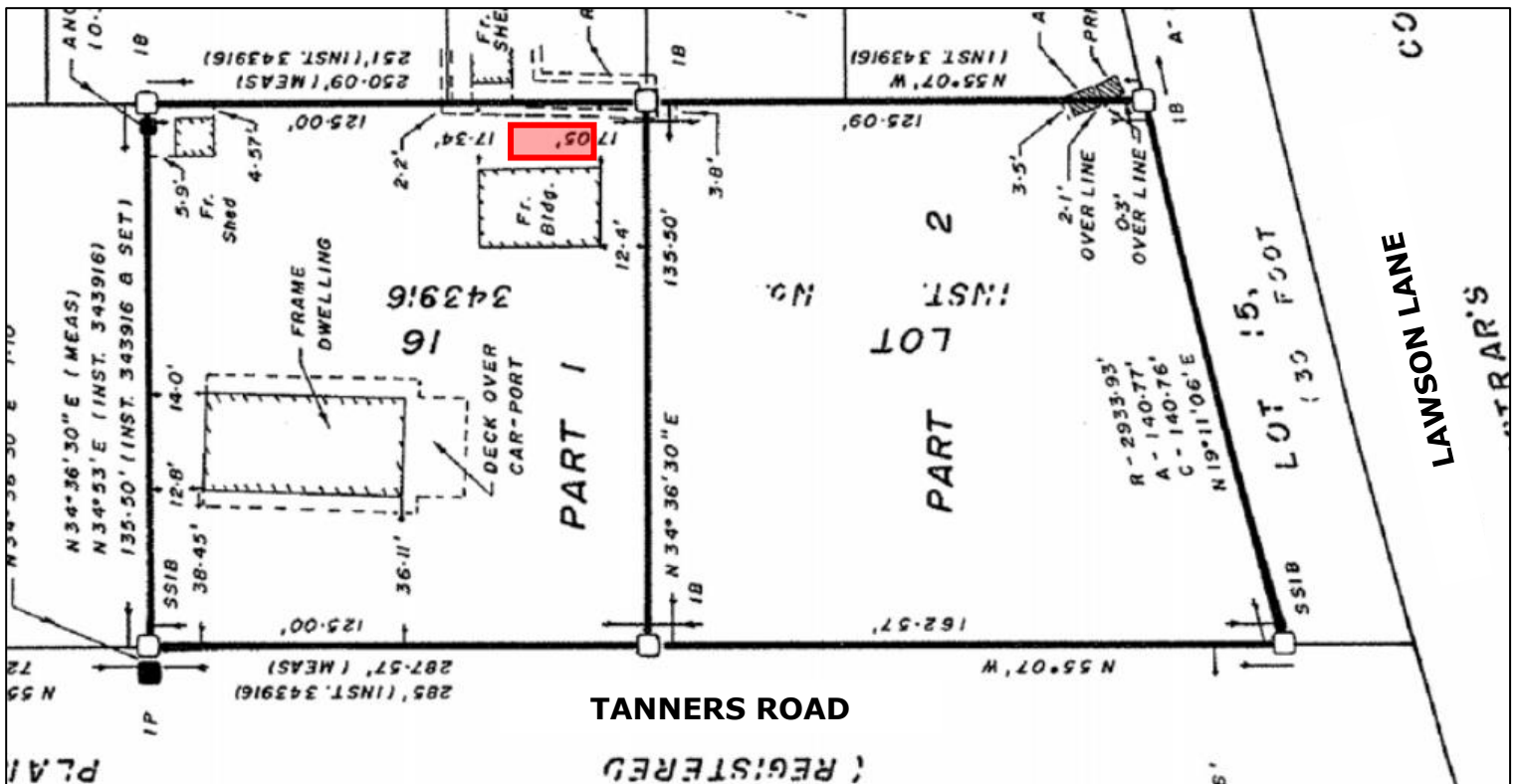
If you wish to be notified of the decision of the Committee of Adjustment in respect of the proposed minor variance, you must make a written request to the Secretary-Treasurer.

**KEY MAP**

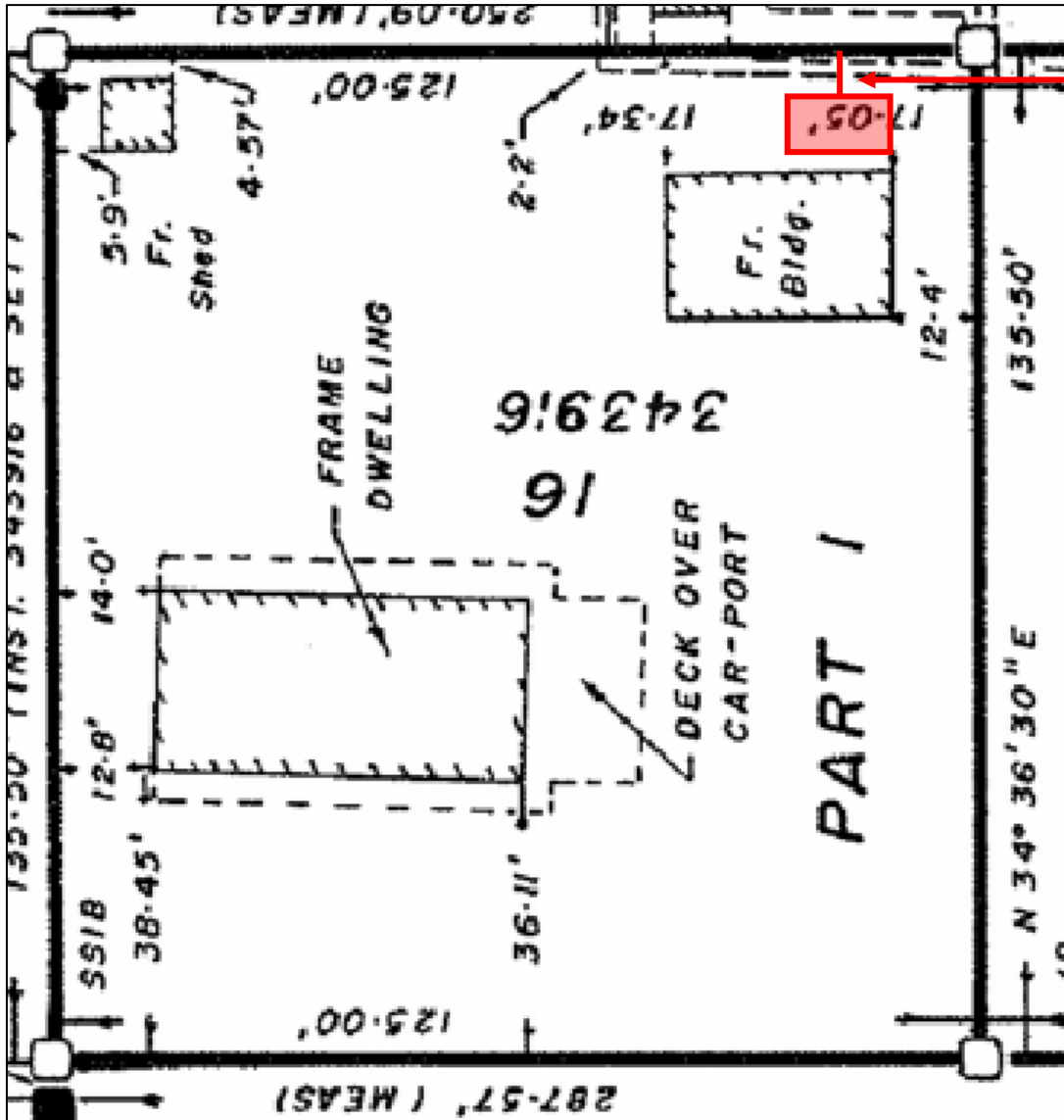


**SURVEY DRAWING**
