NOTICE OF INTENT TO REMOVE A HOLDING (H) SYMBOL

Township of Tay Council has received an application to amend Comprehensive Zoning By-law 2000-57 for the removal of a Holding (H) Symbol. The amendment is being considered under the requirements of the *Planning Act RSO 1990 c.P.13* and applicable regulations. The purpose of this notice is to inform you of this intent and to invite you to hear Council's decision on this matter.

The Proposal: File No.: 2025-06

The purpose of the application is to amend the zoning on the subject lands to remove the "Hold on the Village Residential Two Exception Twenty-one "R2*21(H)" Zone.

The effect of the application is to remove the hold to allow for the development of vacant lots on municipal water and sanitary services.

The subject application concerns multiple vacant lots on Fifth Avenue between Arpin Street and Hayes Street identified on the attached key map.

Your Rights to Appeal:

There is no opportunity for the public to appeal a decision regarding an amending by-law to remove a holding symbol made by the Corporation of the Township of Tay to the Ontario Land Tribunal (OLT).
