Land re-zoned from the Environmental Protection "EP" Zone to the Rural "RU" Zone



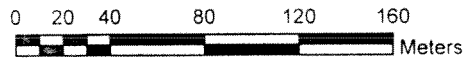
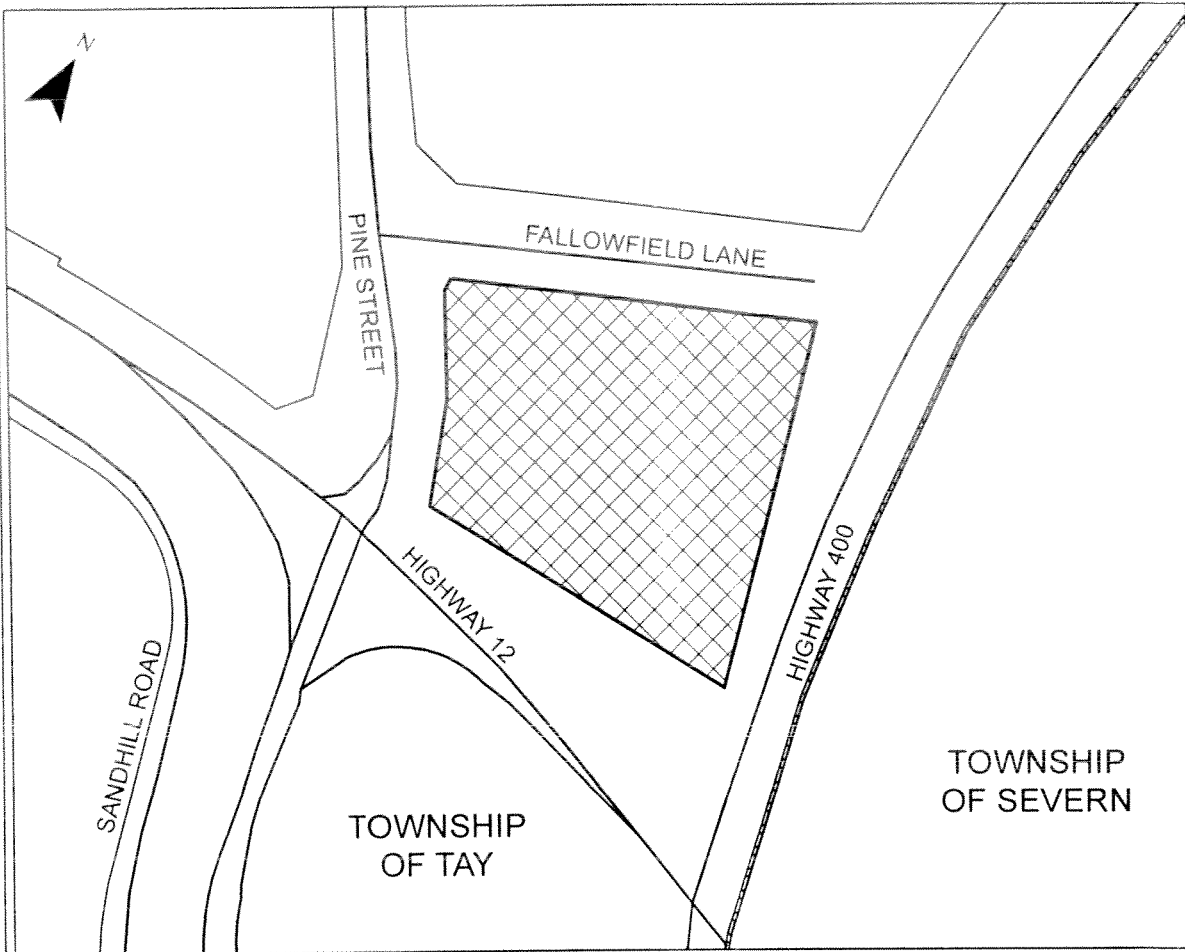
