This is a matter of an application made pursuant to Section 45 of the Planning Act to the Committee of Adjustment submitted by John Richards on behalf of John & Janina Asta, owners of 208 Robins Point Road, legally described as Concession 8, Plan 809, Lot 16, Township of Tay.

The applicant is requesting relief from two (2) provisions of the Township of Tay Zoning By-law 2000-57 as amended. The applicant is requesting permission to permit the construction of a second accessory structure in the front yard and to permit a gazebo less than 15m2 in ground floor area to be located in the front yard, whereas, a maximum of one (1) accessory structure and no accessory structures 15m2 or less in ground floor area are permitted within the front yard.




If you wish to be notified of the decision of the Committee of Adjustment in respect of the proposed minor variance, you must make a written request to the Secretary-Treasurer.


