Lands Rezoned from Rural "RU" to Open Space "OS"




Lands Rezoned from Rural "RU" to Rural Exception Twelve "RU-12"



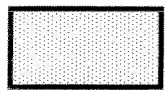

Shoreline Residential "SR" to Shoreline Residential Exception Four "SR-4"



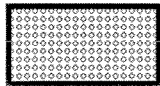
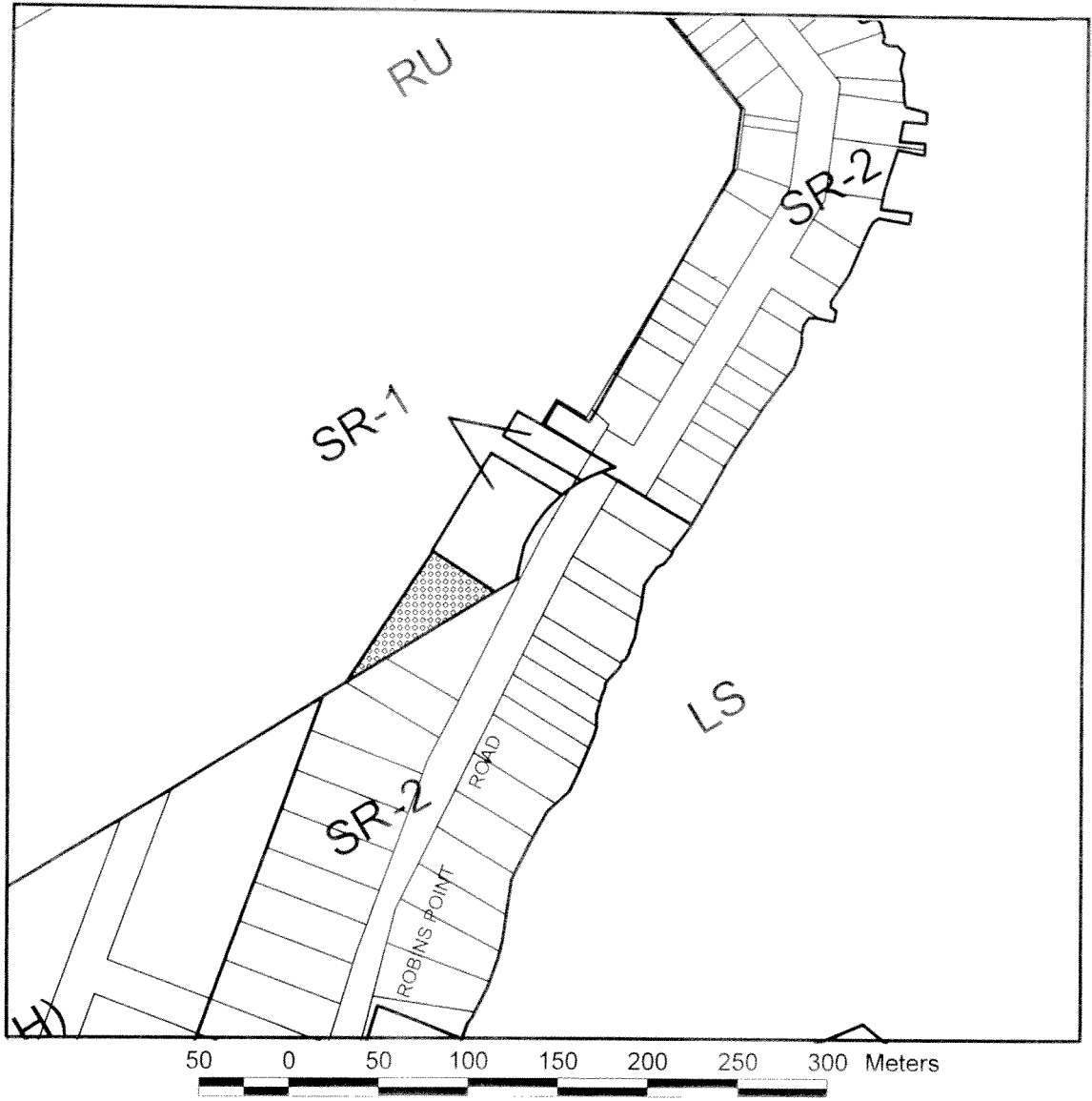


