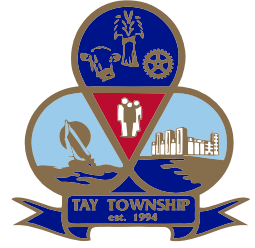

## COMMITTEE OF ADJUSTMENT NOTICE OF MEETING FILE NO. 2024-A-12

This is a matter of an application made pursuant to Section 45 of the Planning Act to the Committee of Adjustment submitted by Scott Quesnelle, owner of **1060 Wood Road**, legally described as Concession 1, Part Lot 76, Registered Plan 51R25465, Part 1, Township of Tay.

The applicant is requesting relief from three (3) provisions of the Township of Tay Zoning By-law 2000-57 as amended, to permit the construction two (2) accessory buildings with reduced yard setbacks. Accessory Building "A" (on the attached site plan) with an interior side yard setback of 5.53 m, whereas 6 m is required. Accessory Building "B" (on the attached site plan) with a rear yard setback of 2.91 m, whereas 3.5 m is required and an interior side yard setback of 3.31 m, whereas 5.0 m is required from a previously approved Minor Variance.

The below chart summarizes the required and proposed reliefs:

Accessory Building "B"	(ii) Minimum Required Yards Rear	3.5 metres (11.48 feet)	2.91 metres (9.54 feet)
Accessory Building "B"	(iii) Minimum Required Yards Interior Side	5.0 metres (16.40 feet)	3.31 metres (10.85 feet)

If you wish to be notified of the decision of the Committee of Adjustment in respect of the proposed minor variance, you must make a written request to the Secretary-Treasurer.

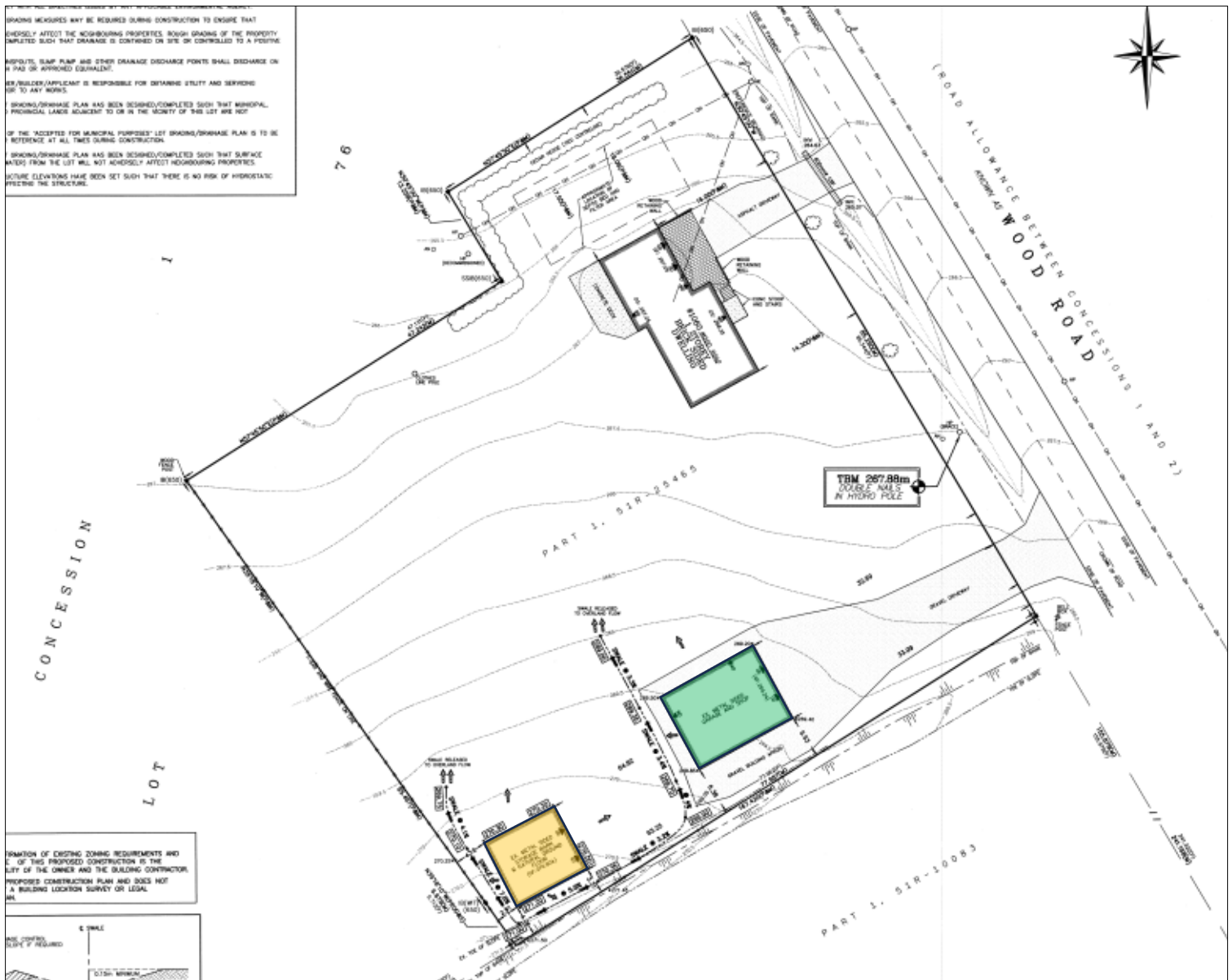
