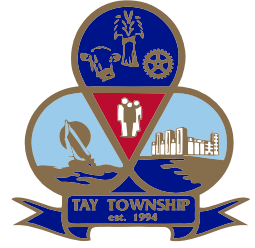

This is a matter of an application made pursuant to Section 53 of the *Planning Act* to the Committee of Adjustment submitted by Neil McFadden on behalf of Donna and Ron McFadden, owners of **5825 Vasey Road**, legally described as Concession 1 East, Part Lot 75, Registered Plan 51R17571, Part 1, Township of Tay.

The application seeks to sever the subject lands to create one (1) new residential lot.
